2020 Issuance of GO Bonds

The District issued \$115 million in General Obligation Bonds in May

- \$65 million from Measure A to finance projects. There are no remaining bonds to be issued from the 2006 Measure A
- \$50 million from Measure G to finance projects. There remain \$750 million in bonds to be issued in the future 2016 Measure G





DISTRICT WIDE 2017 Facilities Technology Master Plan














Leveraging State Matching Funds
