- Approved by Voters on June 5, 2012
- 72.86\% "YES"
$\downarrow \$ 48$ per parcel (senior exemptions)
- Generates approximately $\$ 8$ million per year
- Citizens' Oversight Committee
- Expires June 30, 2020

To provide the College of Alameda, Laney College, Merritt College and Berkeley City College secure funds that cannot be taken by the state, and that support affordable college education including:
providing core academic programs including math, science and English;
training students for successful careers; and educating students to transfer to university...
